Her role is to make sure companies in **rural** Pottawattamie County are happy, healthy, and thriving. If a company is choosing to expand, close, or seek a succession plan, she is

there to give support.

A lot of Shalimar's job is connecting the dots! She helps companies find locations and accompanies them to the state to see what incentives are available. 2022 was a big year bringing in \$79MM capital investment with expansions for Menards and Jack Links. But that was unusual, and she stated it's primarily small businesses that she works with.

The Pottawattamie County Board of Supervisors is the main funder of this work. WIDA served in rural economic development in the past, but now focuses on marketing and promotion of SW Iowa.

Advance Southwest Iowa Corporation is made up of a team besides Shalimar. Paula Hazelwood manages economic development for the city of Council Bluffs through this corporation. Their annual growth of capital investment is approximately \$100MM. Nikki Ferguson is the Manager of Entrepreneurship for Pott Co. helping people who have an idea for a business develop their plan. The Kitchen Council at PACE (Hoff Family Center) managed by Holly Benson Mueller offers a great commercial certified kitchen service to start up caterers and food trucks, saving them lots of dollars to use the space at PACE to experiment and prepare.

and getting her Masters at Seattle Pacific University in Industrial Organization Psychology, she came back to live with her grandparents for four months. She found a job in Omaha, met her husband and has lived here now 12 years. She loves the sense of community and absolutely loves rural Pott. Co. Shalimar is also a graduate of the University of Oklahoma Economic Development Institute.

The group discussed possibilities for future economic development in Treynor. We do not have a large industrial base, but we are a solid, wonderful, beautiful bedroom community to Omaha/Council Bluffs and that's what we are.

Thoughts were discussed with members about what Treynor could support. "The T" will most likely generate future development. Service based businesses such as plumbers, carpenters, electricians, even co-working spaces where a desk is needed for a short time were suggested.

Mike Holton, City Administrator was present and shared the following: Treynor has the need for future growth for a large waste water project which will cost \$6-7MM and is VERY appreciative to be the recipient of a large allocation of money that was granted from a coalition to help rural Pott Co. communities and matched further by Iowa West to total \$1.4 M. Treynor was also the recipient of \$125,000 from the American Rescue Plan Act for a project that was ready to go – moving city hall. This upgrade was done at zero cost to taxpayers.

# Seniors, veterans can apply for new tax break

Applications are due July 1 under new law that provides new tax

Iowa seniors and veterans can begin applying for a new property tax break created by legislation estimate the legislation will result would have associated taxes due +000

The new property tax law, House File 718, was approved with near-unanimous support in the Iowa Legislature. The bill is new property tax revenue growth that local governments can use in their budgets.

It also provides new property tax exemptions for Iowans age 65 and older and for military veterans.

The law provides a \$3,250 exdesigned to limit the amount of emption on the taxable value of a home owned and lived in by Iowans 65 and older as of Jan. 1 of this year. The exemption applies Iowa Homestead Tax Credit, which for the 2023 assessment year that

signed into law earlier this month in a \$100 million property tax cut in fall 2024 and spring 2025. The homestead property tax exemption increases to \$6,500 for the 2024 assessment year. The exemption is a reduction in the taxable value of the property - not a direct reduction in the amount of property taxes owed.

reduces the taxable value of an owner-occupied Iowa home up to \$4,850. Persons in the military or in nursing homes who do not occupy the home are also eligible.

The Iowa Department of Revenue announced Monday it has amended the homestead tax credit exemption form to allow seniors o apply for the new exemption. Applications are due July 1 to local ssessor offices.

If granted, the exemption will be allowed for future years without future filing as long as the claimant continues to qualify, according to the department.

Unlike the Iowa Homestead Tax Credit, however, local governments will not be "backfilled" for the loss in revenue from this part of the new law.

The new law also more than doubles a property tax exemption for veterans by increasing it to \$4,000 in taxable value from the Forms are available at tax.iowa. current \$1,852 in taxable value.

are due July 1 to the local assessor. However, military veterans currently receiving the exemption do not need to file a new application as long as the veteran or the veteran's spouse is the legal or equitable owner of the property on July 1 for which the exemption is allowed, said John Fuller, a spokesperson for the Iowa Department of Revenue.

The exemption applies for a honorably separated, retired, furloughed to a reserve, placed on inactive status or discharged veteran.

Lawmakers passed the bill next year's legislative session.

As with seniors, applications shortly after the latest round of property assessments across Iowa showed widespread, dramatic increases in the assessed value of homes – up a statewide average of 22 percent this year - to keep the rise from triggering dramatic increases in homeowners' local property tax bills.
