Linda Eitmann, St. Paul Preschool

Linda Eitmann, Preschool Administrator of St. Paul Preschool, shared its history and vision. The Preschool was a vision of Linda's after having attended a Minneapolis Conference for Women in 1996. Passion was ignited and persistence paid off for her

vision, and she credits God's guidance with the arrival of Pastor Norris as the turnkey to making it happen by suggesting an exploratory task force, followed by a feasibility study group.

Linda served as Administrator from 2005 – 2012, retired, then came back as Interim 2017-2023. She sees her second and final retirement in the near future.

The Preschool mission is to "Love the children, teach God's wonders, and discover the love of learning."

Linda expressed her pleasure in the Preschool always having high ratings from the state, and now also in a new Quality Rating System known as IQ4K.

Through the years the Preschool plan has grown and currently the Preschool consists of two classrooms with three separate programs/sessions:

- Mon-Fri- ages 4&5
- M,W,F -ages 4&5:
- T,Th -ages 3&4.

Preschool sessions are offered 8:30-11:30. There is also Extended Preschool Care from 7-8:30 & 11:30 – 5:45.

It was notable that four research studies indicate "The gains from Preschool appear to be so significant and consistent that investing in early childhood education is just about the most cost-effective way to spend public money." The benefit is in educational saving, tax earnings, welfare savings, and crime savings.

The future vision involves the fact that Treynor Community School has now opened a Preschool.

Government mandates for a public Preschool are:
1) The teacher have a bachelor degree in early childhood and the associate have a CDA, AA, 2 year career path. 2) 10 hours of instruction without proselytizing during the 10 hours, 3) Only state funding for 4 year olds, 4) School districts set the criteria (such as low income, early access, IEPs, special needs.) 5) Curriculum, assessment and documentation requirement.

St. Paul is a faith based curriculum, offers choice of half day or full day sessions, provides a homey environment/large outdoor classroom area, accepts scholarships and state funding from Child Care Assistance, provides a lower staff to student ratio, and emphasizes monthly service projects.

Linda stated that the impact on St. Paul of also having a public school Preschool in Treynor offers a financial challenge – free versus tuition costs, a possible loss of students, staff wage competition, possible increased tuition, maintenance of the facility being done by the church. At this time being a community partner with the school doesn't seem to be an option.

The unknowns for the future: Will St. Paul enrollment decline? Will the focus be on 3 year olds? Will the Preschool turn into a child care facility? Will the Preschool become a community partner to the school district in the future?

This year there are 37 enrolled, which is a little lower than last year, at the St. Paul Preschool. Thank you, Linda, for pursuing your passion and the service you have provided for hundreds of our children.
