The Board meeting was called to order by Pres. JEFF with eight members plus two Club members present. Treas. RICHARD reported club assets of about \$8600 plus Endowment Fund of \$1338. The Can Kennel policies were reviewed. Abolishment of the withholding fee was approved with the provision that the accumulated reserve is used for Can Kennel improvement. The month of May was approved for Club use of the Can Kennel for scholarships. Cub Scout Pack funding was discussed as our Club is official sponsor of the Pack. \$450 was approved to support Pack activities in addition to \$150 previously approved. A contribution of \$100 was approved for Andrew Carper. Essay, Oratorical, and Youth Celebration expenses of \$109.45 were approved. Iowa District quarterly dues of \$144 were approved for payment. LARRY displayed the enlarged check format to be used for publicity photos when Can Kennel receipts are awarded.

CRUISING THE CANAL

GARY FUNKHOUSER spoke to Club members about the recent trip on the Oosterdam cruise ship that he and Julie went on from Florida through the Panama Canal to California. They were among 1800 passengers and 600 crew on the largest cruise ship that can navigate the canal. GARY explained that there was only 2 ft of space between the canal locks and each side of the ship. Locks, which operated with fresh water, are used to raise the ship from the ocean level about 80 ft to Gatun Lake, which is one of the worlds largest man made lakes. About 36 ships pass through the canal each day. GARY said their ship paid \$30,000 to use the canal. Much of the traffic is from containerized cargo ships going both ways. The canal has been operated by the Panamanian country since 2000 and is in a constant state of improvement to meet the traffic demand. Panama is a cruise destination with many tourist attractions in addition to the canal.

AN INTRODUCTION TO POLICY AND POLITICS

Treynor High School Junior Andrew Carper recently returned from a trip to Washington, DC where he attended the 2005 Presidential Classroom. Andrew said he joined about 300 other high school students from the U.S. and other countries to focus on Science, Technology, and Public Policy. The program was sponsored by Honeywell, Andrew noted, and was held on the campus of Georgetown University. With a smaller group of 40, Andrew stated, he attended lectures by prominent scientists, futurists, military leaders, and educators. The group also debated public policy issues from various points of view. Andrew said he was very grateful for the opportunity to participate in this program and thanked STEVE IRVIN for nominating him.
