Professional Rodeo

Craig Korkow is a recently retired professional rodeo participant. His interest in rodeo started with his grandfather who was recently been honored as a Hall of Fame rodeo person in 2008. Korkow rodeos started in 1947. The Korkows have over 300 horses on their South Dakota ranch. Craig earned 4 state championships in calf roping while in high school and another 4 championships while he was in college. His best time was 7.4 seconds in calf-roping. He discuss the rodeo calendar year which usually begins in Kansas City, and ends in Las Vegas. Craig also showed a short video tape was demonstrating calf-roping.

Craig described the logistics of performing in more than one rodeo during the same weekend. He received a lot of help from his wife and other family members.

slaughtered in the United States, so there is no official way to dispose of older horses. Craig suggests anyone with pasture padlock gates because horses no longer needed might end up on their property because of this problem. They sometimes just get dropped off.

Estates and Beneficiaries

Kerry Monif from Securities America returned to speak about estate planning. She said that everyone has had some type of life changing experience in the past five years, such as a marriage, divorce, death, child or grandchild born, job change, retirement, etc. Therefore, they need to review their beneficiary designation.

A beneficiary designation form takes precedence over a will or trust and cannot be overridden. Therefore, it must be correct and reviewed on a regular basis. Beneficiary designations are specified for life insurance, retirement plans, IRAs, Annuities, and college savings plans.

For a beneficiary form her motto is "Assume Nothing." Many retirement documents contain errors, so it is advisable to have it reviewed by different professionals. Keep a copy of the exact signed form. Be sure it is signed. Make sure you have not left any designations blank; otherwise the assets can default to the estate. When part of the estate they are subject to the delays and costs of probate court.
