## Iowa State Senate



Tom Shipley, an Iowa State Senator, spoke at the Treynor Optimist Club on April 11. He was born and raised in Adams County. He graduated from Villisca High School, Iowa Western Community College and Iowa State University.

His bachelor's degree was in Agriculture Education. He has devoted much of his life to agriculture. He has a small farming operation and cow herd at Nodaway.

He is State Senator of District 11, which is the 2<sup>nd</sup> largest district by area in the state. He communicates to the public through a newsletter. His email is tom.shipley@legis.iowa.gov

The budget is still not set because of the school budget not being settled. The House wants a 1.25 percent increase and the Senate wants a 4.0 percent increase. Asked if they would have an arbitrator assist, he said that if the rate is not set by July 1<sup>st</sup> the rate will not change from last year.

Tom talked of wanting to be responsible to not spend more than we have. Corn prices are still down which affects industry in Iowa in many ways others than just the farmer. He has been told Medicare will increase next year but is unsure why. He talked about the gas tax and how it will help with the roads and bridges we use every day. He felt

In 1952, Armon M. Sweat, Jr., a member of the Texas House of Representatives, was asked about his position on whiskey. What follows is his exact answer (taken from the Political Archives of Texas):

"However, if by whiskey you mean the lubricant of conversation, the philosophic juice, the elixir of life, the liquid that is consumed when good fellows get together, that puts a song in their hearts and the warm glow of contentment in their eyes; if you mean Christmas cheer, the stimulating sip that puts a little spring in the step of an elderly gentleman on a frosty morning; if you mean that drink that enables man to magnify his joy, and to forget life's great tragedies and heartbreaks and sorrow; if you mean that drink the sale of which pours into Texas treasuries untold millions of dollars each year, that provides tender care for our little crippled children, our blind, our deaf, our dumb, our pitifully aged and infirm, to build the finest highways, hospitals, universities, and community colleges in this nation, then my friend, I am absolutely, unequivocally in favor of it.

"This is my position, and as always, I refuse to compromise on matters of principle."
