## Mary Jewell, TS Prosperity Group

Mary Jewell, Vice President and Fiduciary Officer of TS Prosperity Group (TSPG), spoke at the meeting of the Optimist Club of Treynor on Saturday, Dec. 16. Mary has a law degree from Creighton University and has worked at TS Bank for five years. Her prior work experience includes charitable gift planning, donor development, and a trust officer. She is the mother of 6 children and she and her husband, Rod, live in Omaha.



Mary expressed that she loves helping people. The tagline of TS Bank is to Ignite Prosperity and her job is helping people with their money.

A practical, down-to-earth lady who has been involved in all kinds of cases, Mary expressed the following common sense advice: "*It's important to be able to sleep at night knowing rates will eventually go down.*" The bank has a department of analysts who focus on researching investments and together they help clients figure out what types of investments are appropriate for them while yielding a good rate, but also minimizing risk.

She also helps develop estate plans for clients and had many stories to share. Another common sense statement: **"None of us knows how the day will end."** Two musts are having 1) a <u>Health</u> <u>Care Power of Attorney</u> document and 2) a <u>Durable Power of Attorney</u> document for finances. make decisions regarding health and finances in case you are unable. She recommends talking to the person(s) you designate so that person understands your wishes.

Mary also stated: "*I'm the shoemaker without the shoes.*" She indicated her adult children are single and she is planning on giving them their own Powers of Attorney for Health for Christmas!

Upon death is when a will goes into effect and the will identifies a representative (personal representative, executor or administrator) named in the will to handle your affairs. *"Will your children still have Christmas dinner together?"* Siblings fighting over stuff in the home is very common – the Kool Aid pitcher and Mom's diamond ring. In NE and IA, you can have a handwritten laundry list designating who gets what.

Setting up a trust avoids probate and is more private. There are some charges, some processes to do this, but it can be a very effective way to handle your affairs. Trustees can be whomever you name, but the bank can also serve in this capacity. TSPG also works with conservatorships to help with the accounts of people with special needs.

*"The State is where it ends up if you have no plan."* She expressed the goal of TS Prosperity Group is to make you money and encourage you to get your money where you want it – family members, charities. She said, *"Get your paperwork done and make sure you review your IRA beneficiaries. Keep up to date."* TS Prosperity Group is willing to help.
