## **Retirement Planning**

Ann Vorthmann introduced speaker, Craig Korkow, at the Treynor Optimist Club meeting on

Craig graduated from Treynor High School in 1992 and graduated in economics from South Dakota State University. He

spent four years serving in the US Army before leaving as a Captain and joining Merrill Lynch. Craig is a Certified Financial Planner and Certified Retirement Planning Counselor and recently was named Resident Director of Merrill Lynch in Omaha.

Craig discussed four key retirement risks and the importance of planning ahead for them. Two risks are personal risks: Longevity and Health Care; and two risks are market risks: Sequence of Returns and Inflation. Longevity risk is the risk of outliving your wealth - living longer than anticipated. Health care risk is the rising costs of health care and the potential for depleted retirement savings. The risk associated with a long-term-care event is of particular concern. Craig explained that market risks including sequence of returns and inflation are valid retirement risks as well.

Craig's advice for avoiding retirement risks is to plan ahead. Contact a certified financial planner early and begin planning for a secure retirement. Craig and his wife, Tonja, live on an acreage east of Council Bluffs.
