Mary Mosiman, State Auditor

Mary Mosiman, Auditor of the State of Iowa, spoke to the Treynor Optimist Club on Saturday, February 17. She was born and raised on a hog farm near Hubbard. She met her husband at ISU and lives in the Ames area. They have four daughters.

employees, 88 are auditors, four are IT, and the remainder are support personnel.

Mosiman indicated that for 30 years lowa's budgeted expenses were greater than income. Since 2011, that has been reversed. She emphasized the #1 basic budgeting principle is: Expenses should not exceed income.

Total Appropriations for the State Budget have been reduced for FY 18: The change is impacting Health and Human Services and Education the most. In addition, Ag & Natural Resources, Justice, and Transportation have reductions.

lowa Legislator Jon Jacobsen, Vice Chairman of the Education Committee, stated that in the last seven years, lowa has the third highest increase in education spending in the US. An issue being addressed is trying to provide rural transportation equity for students. He would like to see more private monies used to help with education. In Fiscal Year (FY) 2016 there was a \$367.3 million surplus carryforward, which has diminished to 0 for the FY Budget for 2018. She emphasized surplus carryforward is not a reliable ongoing source of revenue. It should only be used for one-time projects. That surplus is now gone.

Ninety per cent of resources come through the general fund from personal income tax and sales/use tax. In FY 17 and FY 18 total resources are very close to total expenses. A graph of revenue variance since 2006 was reviewed and we are in an unusual period of four years where revenue is lower than expected. A factor is the decline in the ag economy. Sales/Use tax has declined with people increasing the convenient practice of purchasing online. Amazon does pay taxes back to lowa but only if the vendors are in lowa. Baby Boomers are retiring and the Millennials and Gen Z group work 37.5 hours so are taxed at a lesser rate so less income tax.

Jacobsen commented that reduced corporate and personal federal income taxes should have a positive impact in Iowa of \$20-30 million. Mosiman said there is lots of optimism.

She concluded by stating the FY 2018 budget is balanced, stable and responsible. They had to borrow from reserve funds, but the budget was balanced from the beginning.
