Cheryl Clark Speaks Today

Cheryl Clark, VP of Resource Development at Children's Square in Council Bluffs, spoke to the Treynor Optimists on Saturday, February 1 at the Treynor Community Building. Her family roots are from the Dunlap, Woodbine, Denison area.



Clark has worked at Children's Square for seven months in fundraising, marketing and community relations, following a similar job with the Omaha Salvation Army. Her first career was in financial advisory services with a Wall Street firm in various states around the country. Cheryl stated: "There is no place that has the same values as the Midwest."

Clark shared the rich history of Children's Square, describing first the Great Flood on the Missouri River in 1881, which resulted in typhoid fever, hunger, and homelessness. As a result, Rev. Lemon started Children's Square as a way to help families. At first it served as an orphanage and adoption agency. A father of three lost his wife to illness and brought his three children to Rev. Lemon.

In the 70's to help with societal changes, Children's Square ramped up programs to focus on solutions. Today there are nine programs focusing on educational services, child welfare and emergency services, and behavioral health.

Some interesting facts: Children's Square helps children from infants to age 21. 25% of the children range from ages 8-10, and 25% are young teens. 80% of the kids come from one-parent families. Approximately 1000 children are cared for daily, with a large percentage coming from Pottawattamie, Harrison and Mills Cos. The average child stay is six months, some for two years. The school on campus is certified and runs under the CB Public Schools.

Children's Square is a unique agency in the U.S. It is a therapeutic model, not a disciplinary or boot camp model. The cottages, led by a house parent, are locked to keep people from coming in, but the children, although supervised, can leave. Medicaid in Iowa reimburses Children's Square \$207/day for each child, which is the lowest rate in the nation. (Nebraska is 40% higher.) The need is greater than that. Thus, Clark's role is to encourage visits with legislators and to seek funding from outside sources and donors. She handed out their current needs lists which includes clothes especially for teens, legislative coffees schedule, and legislator contact info. New Business:


Studio 7 Dance Team will meet this Wednesday, Feb. 5 at 4:00 to sort cans at the Can Kennel.
