Martin Cannon, "Free Speech America"

Martin Cannon from Council Bluffs is an attorney



for the Thomas More Society, a national public interest law firm dedicated to protecting religious freedom, life and traditional family values. His main focus has been pro-life and the right to speak publicly about that. There is a focus on the

First Amendment grown from pro-life work in the past.

He stated free speech itself has now come under attack. It is highly curtailed in today's environment. Cannon stated you can't protect babies if you can't protect the right to speak about it. It overarches all issues regardless of political party.

Cannon cited many freedom of speech cases. Just a few years ago if someone said something objectionable, you might have heard an employer of that person say, "We don't agree and he's not speaking for us." Today the response is "We fired him (her). We took away his license to practice law, etc."

Debate was the healthy norm and has now been replaced with penalties for speaking. The action is against the speaker rather than action for the speech.

If one goes to the Capitol in Des Moines to discuss an issue, the halls are filled with people to make their voices heard. People show up in numbers to create political pressure. One can't say any words that directly incite violence. Then speech is not protected under law.

Cannon stated the Constitution only protects you from your government. The government can't impair free speech. Neighbors and employers can do that unless government is the employer, which includes schools. The cancel culture is mostly going on in the hands of private enterprise. Disney can assault; the

constitution doesn't prohibit that. For every government act, there are 100 assaults on free speech related to private enterprise.

Assault on free speech from the government is prohibited by the constitution. He stated the most dangerous thing is the pervasiveness of intervention of private enterprise.

Cannon stated: Fear and silence ensues. People that respect the freedoms have to get in the game. If you don't like the offensive speech, we need more speech. Instead this practice is being stifled. That's what gets you on the road to something horrible.

Solution: People who respect speech and the right to debate must get in the debate! One side is absent. What are we doing? We are showing cowardice. The process must be respected. People get power from their ability to speak. Get in the debate. Don't be apologetic. If social media is depriving platforms, it tells you that they can't be trusted. Where do we go as a society when people who control our public discourse are skewing it?

Consider the executive order. We didn't hear of it 10 years ago and now government is running the country with it. Why? Refusal of debate creates imperial executives. Why are legislators not debating issues that govern us? We no longer agree on the fundamentals.
