Melvin Houser, Pottawattamie Co. Auditor

Houser stated the Auditor's office is the busiest office in the court house.

April is National County Government Month. He said when he first became Auditor in 2017, he had no idea of that fact. When asked by a reporter what he planned to do to celebrate the month, that's what was put in the paper – "He had no idea."

He stated that surveys indicate only 20% of people trust in the national government, 40-50% in state government, 80% trust in local government and 100% probably in Treynor except for dog issues!

Houser worked 16 years as a Pott. County Supervisor and worked closely with the former Auditor, Marilyn Drake. Drake had said, "All that happens in the Auditor's office is pure chaos." Melvin said, "And that is the way it is!"

There are eleven on the staff, many long-time employees, and it is the hub of county government and budget central for all schools, cities, community colleges and the Board of Supervisors. The Office also clerks and keeps the minutes for the Board of Supervisors so he meets every Tuesday with them. A board administrative assistant actually takes the minutes and he assures they are correct and published.

Melvin stated that the Treasurer pays all bills, payroll, and records incoming money, but money then goes out through the Audit Office. Also the Auditor is the custodian of the courthouse and all the buildings. He stated the Adams Co. Auditor in Corning unplugs toilets, takes care of snowmelt,

and is janitor, but he's thankful that Pott. Co. has a Building and Grounds Division.

Before the 70's, each entity in the county (schools, etc.) had its own elections, but in 1972 it was changed federally that the auditor run all elections. They do lots of crosschecking with obituaries, kids getting drivers' licenses and fraud prevention. Unknown to most, he stated elections take months to prepare and months to clean up after.

When asked, Houser stated when he first took office in 2017, immediately the IRS did their first ever audit of the payroll division. It was clean, but the finance division hadn't been sending W-9's from vendors and was fined \$18,000. He said he talked to others in the state and none had ever had an IRS audit. Melvin asked if there was a red flag for Pott. Co. to be audited, but he was told the IRS wanted to start auditing small government offices.

Melvin stated that auditing in the Auditors Department is not the same as a state auditor or a CPA would do.

Melvin also spoke about the payroll process and how it needs to improve. Many of the county employees do negotiate salaries because there are six unions, four of which are the jail, roads, courthouse, and 911.

Additional topics discussed were: hiring, reduction of taxes for people over 65, paying taxes online, mail-in ballots, and financial efficiency.

Many of the volunteer poll workers are older and young poll workers are needed. If you are interested, contact the Auditor's Office.
